SCF has undergone strategic planning to ensure we are responsive to key issues in our community. Our granting focus on the first 2000 days of life has supported projects which will help to define a healthier, more resilient generation of young people to come. As well, in 2016 board and staff united in the decision to make reconciliation issues a major focus for our activities in 2016 and the years to come. SCF signed the Philanthropic Community's Call to Action on the Truth and Reconciliation Commission's 94 recommendations. Our staff participated in the reconciliation walk, Reconciliation Gathering at Wanuskewin, and the Wichihitowin Conference on Aboriginal Engagement. We also sponsored a screening of the Gord Downie film "The Secret Path."

Random Act of Kindness Day set new records for participation and helped to spur the growing success of our social media, with more volunteers and more Kindness Crews than ever before, keeping SCF present in the public eye. The PotashCorp Saskatoon Community Foundation Cultural Gala celebrated its Diamond Anniversary, earning \$225,000.00 for our community. It gave us a chance to recognize the special contributions of Donald and Mardele Atchison by creating a permanent endowed fund in their name.

With many changes on the world scene, 2016 was a challenging year for any organization involved in management of investments. Despite somewhat lower returns in 2015 of 2.02 percent, our accumulated surplus from 2013 and 2014 allowed SCF to continue to grant at its typical level of 3.5% in 2016. This is the

strength of our long-term endowment model. The market may fluctuate, but our management strategy allows us to maintain consistent support to our community through challenging times. The Foundation implemented a new Statement of Investment Principles for our investments. The Statement was developed by our Investment Committee under the guidance of AON Hewitt and approved by our Board. The Statement's asset mix is designed to provide stable long term returns and now makes provision for investments in real estate and mortgage pooled funds.

Since 1970, the Saskatoon Community Foundation has been building a base of support for local charities that will last forever. As our funds grow, so does our ability to help our community. In 2016, SCF continued its high level of support for the community with \$5.17 million in grants, bringing our total grants since 1970 to over \$29 million! The majority of these millions have been granted in recent years, and this will continue to grow in future. Our donors have continued to put their trust in the community foundation's management, with \$2.3 million in gifts received in 2016. It was a challenging year in the financial markets, with our investments earning a return of 3.22%, which brings our 10 year average return to 5.11%.

The Saskatoon Community Foundation would like to thank the thousands of donors who have helped to build a permanent base of support for local charities, creating legacies and memorializing the citizens who shaped our community. Your community makes you and you make your community!

GRANT PROFILES

THE FIRST 2,000 DAYS OF LIFE



2016 MARKED SCF'S SECOND YEAR
OF GRANTS TO SUPPORT YOUNG
CHILDREN. BEGINNING IN 2015, OUR
BOARD OF DIRECTORS CHALLENGED
OUR GRANTS COMMITTEE TO FOCUS
OUR EFFORTS TO CREATE THE
MAXIMUM IMPACT POSSIBLE WITH OUR
LIMITED GRANT FUNDS.

Through consultation with experts and the body of research, it was decided that the best opportunity to make an impact on the quality of life in the community was by making grants to help the youngest citizens of Saskatoon, during the first 2,000 days of life. During this period, children learn crucial skills and social patterns that will affect their lives in the years to come. SCF continues to make a wide variety of grants to many types of projects. Our early years focus for our

grants will bear fruit for our community as these kids become the next generation of leaders and innovators, healthy, strong, and with the support they need to succeed. The following pages profile a few of those grants.





READ SASKATOON'S FAMILY LITERACY LEARNING CENTRE

IN 2016, READ SASKATOON ACQUIRED NEW OFFICE SPACE WITH A LONG-TERM LEASE. KNOWING THEY WILL HAVE THEIR NEW SPACE FOR MANY YEARS, READ APPROACHED SCF FOR ASSISTANCE IN CREATING A LEARNING SPACE FOR FAMILIES AND CHILDREN.

Our 2016 Signature Grant helped to create the Family Literacy Learning Centre. The Centre provides many ongoing and long-lasting benefits for children and those who work with children in our community. The learning outcomes for families and kids will include increased literacy activities for parents to support their children's emerging literacy development, enhanced parent/child engagement, increased awareness of community involvement and interaction, and increased facilitation skills, tools, and strategies for working

with children and their families. As part of the new lease arrangements, READ sublets space to two other organizations, the MS Society and the Arthritis Society, both of which can use the space for their programs for young children as well. Likewise, READ has longstanding partnerships with many organizations in the community, to ensure that the space is always providing benefits to our community, particularly its youngest citizens!

FASD INTENSIVE FAMILY SUPPORT



FASD REMAINS A LARGELY
MISUNDERSTOOD DISORDER. SOME
OF THE PROMINENT NEWS STORIES
FOCUS ON THE STEREOTYPICAL FACIAL
CHARACTERISTICS, BUT ACTUALLY 90%
OF PEOPLE LIVING WITH FASD DO NOT
HAVE THOSE TRAITS.

Likewise, because the presence of any alcohol, even one drink, in the system during the first few weeks of pregnancy can cause a wide range of changes to the development of the embryo, anyone can be affected not just people with serious substance issues. The largest risk groups are university age women and single professionals in their 30s. Children living with FASD may experience unusual challenges in behaviour and processing of information in the brain. The FASD

Network helps families dealing with FASD find the supports and services they need to address these challenges. Occupational therapists, like those at Theraplay (pictured), can provide programs of sensory stimulation that assist the children in processing information, help improve behaviour and give children the support they need to live better lives. \$\mathbb{C}\$





CARE & SHARE BABYSITTER PROGRAM

THE SAFETY OF CHILDREN IS A TOP PRIORITY IN EVERY COMMUNITY. HOWEVER, MANY CHILDREN ARE FREQUENTLY LEFT IN THE CARE OF OTHER CHILDREN, WHETHER DUE TO WORKING PARENTS OR OTHER CHALLENGES FACED BY THE FAMILY.

Care and Share partners with St. John Ambulance to provide over 200 children each year with the skills they need to safely care for other kids, whether they are needed by their own families to care for siblings or can earn their first form of income by babysitting for others. The course teaches infant care from how to safely heat milk or formula to how to correctly diaper a baby. It teaches basic home safety, CPR, diet and other skills needed to watch over young ones.

The babysitting program teaches new skills to 11 and 12 year olds which will help to keep younger kids safe, happy and secure, and which will also serve them well as they eventually become parents themselves.

YWCA MOMS & KIDS GROUP



FAMILIES AT THE YWCA SHELTER NEED MORE THAN JUST A PLACE TO STAY.

MANY OF THE MOMS STAYING AT THE SHELTER NEED ACCESS TO RESOURCES AND POSITIVE MODELS TO IMPROVE RELATIONSHIPS WITH THEIR CHILDREN.

The YWCA Moms and Kids Group provides moms with tools to build nurturing parent-child relationships and secure attachments. The group allows women who are living in highly stressed situations the ability to relax in a safe setting and build relationships with their children, regardless of the severity of their current crises. Moms learn tools to create closer bonds with their children, including hands-on role modeling to develop skills to support their children's early learning

and development, education to assist moms with caring for their children, and support in building strategies to cope with the stressful realities and frustrations of everyday parenting.

Activities offered for the families include cooking, playing games, outings, and crafts, all of which help the moms on their journey to closer and more nurturing bonds with their children.





AUTISM SUMMER PROGRAM

AUTISM SERVICES SUMMER PROGRAM OFFERS CHILDREN AND YOUTH FROM AGES 3–19 DIAGNOSED WITH AUTISM THE OPPORTUNITY TO PARTICIPATE IN WEEK LONG DAY CAMPS. THE SUMMER PLAYTIME CAMP SERVES KIDS AGED 3–6. GROUPS IN THIS CAMP ARE SMALLER WITH HIGH STAFF RATIOS TO ACCOMMODATE THE NEEDS OF YOUNGER CLIENTS.

Activities include the spray park,
Children's Museum, and Kinsmen Park.
Autism consultants also provide specific
behavior plans to be implemented during
the course of the recreational activities.
Some of the main behavioural target
areas include transitions, taking turns,
waiting and communication. Autism
Services also provides camps such as
the Awesome Adventures camp and the
Fun in the City camp for children and
youth aged 7-19. Activities are chosen
based on the level of supervision and
support required, including horse riding

therapy, bowling, swimming, day trips to Blackstrap and Pike Lake, trips to the Forestry Farm, Western Development Museum, Meewasin Valley Centre and more! The camps promote a healthy, active environment for individuals with autism spectrum disorders by providing them with opportunities to engage with peers in a safe and supportive area. They also provide respite care for parents/ caregivers of children and youth. **L*

2016 POTASHCORP CHILDREN'S FESTIVAL




ON JUNE 4-7, 2016, THE 28TH ANNUAL CHILDREN'S FESTIVAL WAS HELD IN KIWANIS PARK AND WAS ATTENDED BY OVER 8000 PEOPLE. FREE FESTIVAL PASSES WERE DISTRIBUTED TO CHILDREN WHO FACE SOCIAL, PHYSICAL OR FINANCIAL BARRIERS TO PARTICIPATION.

As well, 56 school classes, typically local Community Schools, received wholly or partially subsidized tickets. The Children's Festival plans progressive programming which evolves to reflect our ever-changing community. In 2016, the Art français venue increased the Francophone content at the Festival. The Childhood Around the World venue offered more for the newcomer communities of Saskatoon, and the translation of the welcome message into Cree was

more inclusive of First Nations. The Children's Festival features a unique combination of performances for young audiences and interactive venues that allow kids 5 and under to engage in stimulating play. 2016 programming for this age group included: the very popular children's musician Norman Foote; the comedy/magic show Kid's Mega Magic Show; street circus artists including Gustavo The Impossiblist, The Hockey Circus Show and the Silver Starlets aerial act; the incredibly popular Lego Community Build; the KinderGarden venue (featuring the Imagination Playground, gigantic foam bricks that can be used to build large structures); "Music and Movement" workshops from Move N Soar; interactive hula hoop workshops; and story-telling venues, among other attractions. ::

JERET & KELLY BODE FAMILY FUND


JERET AND KELLY BODE ARE BOTH

BRAY FAMILY FUNDS



DR. GORDON AND BETTY BRAY HAVE

OUR COMMUNITY THROUGH BUILDING
ENDOWMENTS.

Like many donors, Gordon and Betty contributed regularly over the years, and through accumulated contributions, established a Designated Fund, the Dr. Gordon & Betty Bray Fund for Shakespeare on the Saskatchewan. But their contributions did not stop there.

Both Betty and Gordon were involved with the community in many roles. They counted their blessings and wanted to pass it on as best as they could though volunteerism. In addition to sitting on the SCF Board. Gordon was also a board member at the Saskatoon City Hospital. He was president of the Canadian Association of Radiologists and was also invited to become the first Canadian on the American College of Radiology Steering Committee. Betty received her Bachelor of Social Work after she raised her children, and worked closely with non-profits, such as Big Sisters. She sat on the boards for the Persephone Theatre, the Mendel Art Gallery and on the national board for the YWCA. Betty was also a role model, becoming the first female board chair of the United Way of Saskatoon.

Their contributions to the Saskatoon community continued after their passing. The Brays created a Community Builder Agreement with SCF through a life insurance policy and through their wills. The agreement directed SCF to continue their contributions to the community. Funds from their life insurance policy established the **Dr. Gordon & Betty Bray Memorial Fund, a Designated Fund,** to benefit their chosen charities of the United Way, Remai Modern Art Gallery, YWCA and the Saskatoon Community Foundation administration.

The Brays supported the art scene in Saskatoon through volunteering and by attending many performances. They saw the arts as a reflection of life, mirroring human nature and our course of action through each period of time. They wished to continue to support the arts and to address a concern that, when times are



hard, funding for the arts always seems to be the first to go. Their Community Builder Agreement with the Saskatoon Community Foundation arranged for a bequest from their estate to create the **Dr. Gordon & Betty Bray Arts Fund, a Donor Designated Fund**, to support the Persephone Theatre and the Saskatoon Symphony.

Throughout their lives, Gordon and Betty taught their children the importance and benefits of philanthropy. To enhance their children's philanthropy experience, the Brays left the Saskatoon Community Foundation additional funds, with direction to be stipulated by their children, Scott Bray and Linda Gillis. Linda chose to establish the Bray Memorial Shelter for Women and the Bray Memorial Welcoming Fund, both Flow Through Funds, while Scott Bray created the Bray Memorial Community Fund, an Unrestricted Fund and the Bray Memorial Fund, a Designated Fund, which supports Shakespeare on the Saskatchewan and the Sherbrooke Community Society.

In the future, Linda and Scott will continue to grow the established funds over time, while Scott and his wife, Carolyn, are looking to follow Betty and Gordon's path by establishing their own Community Builder Agreement. Scott is excited about the work that the SCF is doing on Reconciliation and wants to be involved. In his own words, Scott reflects, "There is joy and contentment in knowing others will continue to enjoy the benefits of these funds long after we are gone. These legacies last forever. If anyone feels strong enough to leave a legacy, don't wait and do it now. Start small and build."

Brian grew up on a farm near Plumas, Manitoba and Laurel on a farm near Stony Beach, Saskatchewan, Brian studied at the University of Manitoba for his undergraduate and PhD degrees in Agriculture and Laurel graduated from Red River Community College in Winnipeg. They moved to Saskatoon in 1977 where they both began lengthy careers at the University of Saskatchewan. Brian spent 35 successful years as a member of the Crop Development Centre, College of Agriculture and continues to pursue parttime research interests as Distinguished Professor Emeritus since retirement in 2011. Laurel retired in 2005 after 30. years in various administrative positions including 16 years with University Advancement giving both she and Brian a good understanding of the challenges and rewards of fundraising. Since then she has pursued her art, spent more time golfing, helped her parents in their senior years and volunteered for favorite causes.

During his career Brian has volunteered extensively in the agriculture arena at the local, provincial, national and international level receiving a number of recognition awards for that leadership and effort. At present, Brian is Board Chair of Prairieland Park Corporation. He has also been an active member of the Saskatoon Prostate Support Group for the past few years. Having volunteered for several local organizations in the past, Laurel spent 2011 on the Mendel Art Board of Trustees and five years as a board member at Riverside Country Club.

Experiencing the failing health of elderly parents created increased knowledge of the health system and recognition of the value of contributions to Saskatoon's hospitals and health organizations. SASKATOON COMMUNITY FOUNDATION
MADE RECONCILIATION AN AREA
OF FOCUS FOR OUR ACTIVITIES IN
SUPPORTING THE DEVELOPMENT OF OUR
VIBRANT COMMUNITY.

Between the late 1880s and 1996, the residential school system took over 150,000 indigenous children from their homes, families and communities. According to Justice Murray Sinclair, head of the TRC, at least 6000 children died in the care of that system. However, the federal government stopped recording the deaths around 1920 after the chief medical officer at Indian Affairs suggested children were dying at an alarming rate. The TRC fears that the number may have been as many as 30,000.

In June 2016, the Board of Directors for SCF signed the Philanthropic Community's Declaration of Action on the TRC. SCF staff participated in the Walk for Reconciliation in June, participated in the National Reconciliation Gathering at Wanuskewin in June, and attended the Wicihitowin Conference on Aboriginal Engagement in October. Also in October, SCF assisted in presenting a public screening of the animated film, The Secret Path, written and directed by and featuring the music of Gord Downie of the Tragically Hip, which tells the story of a young man who died trying to escape his residential school in 1966. Over the last three years, indigeous representation has begun to grow on SCF committees, most particularly the Grants Committee. As our relationships grow, we look to a more inclusive future, with a better representation of all the cultures and concerns that make up our community.

The task is not easy. Community foundations, as per CRA regulations support registered charities with their grants. However, very few charities across Canada or in Saskatoon have a distinctly indigenous focus, though many do serve a significant number of indigenous people. So, in order for SCF to focus its granting on themes of reconciliation, we must seek out new partnerships between charities, indigenous groups or programs that may not have charitable status, and other funders who can assist us in projects that can improve indigenous and nonindigenous communities in Saskatoon and area.

"RECONCILIATION CANNOT BE DELEGATED."

It has to be real and genuine. It has to be everyone's job. You sincerely respect the people and relationships you build with them. At SCF, we don't yet know all the possible paths and directions that our reconciliation journey will take. We don't know, any more than any Canadian, where our work will take us. We begin by acknowledging the truth of the past, committing as people and as an organization to work toward healing, and seeking a vision of a better future in which we can proudly proclaim Canada the "true north, strong and free." 13

YOUTH ENDOWMENT SASKATOON

In order to support its development of Youth in Philanthropy, SCF created a special fund for youth projects. Many donors came together with many gifts in 2002 to create the fund which was then known as the Batting 1000 Endowment for Children and Youth. In 2004, our newly created Youth Advisory Council made its first round of grants from the fund. Since then, each year, a new group of youth has come together to learn about charity, set priorities for youth projects, and make

grants from the fund. In 2012, the YAC renamed the fund Youth Endowment Saskatoon, creating the anagram, YES! This new name reflects the positive spirit of youth, as well as the YAC's desire to say YES! to requests for support!

When you decide to establish an endowment fund with the Saskatoon Community Foundation, you are making a lasting commitment to the future of our community. You can make gifts of cash, a designation in your will, a life insurance policy, real estate, or a gift of appreciated publicly traded securities. These gifts to the Foundation are invested in perpetuity with the income granted to charitable organizations. This means your original gift will make an impact in the community today, tomorrow, and forever.

TYPES OF FUNDS

Unrestricted Funds provide the Foundation with the most flexibility in responding to grant applications. This type of fund is not tied to any specific agency or field of interest, which allows the Foundation to address pressing, changing needs of the community.

Field of Interest Funds are established by donors who wish to support a specific charitable field of interest, such as arts, education, health, family and community, or the environment. Based on the donor's field of interest, the Foundation selects appropriate projects to support.

Donor Designated Funds are established by donors to support one or more specific charitable organizations in perpetuity.

Donor Advised Funds enable donors to be actively involved each year in recommending recipient charities.

Student Awards are established in the name of a donor, or in honour of someone else, to help individuals receive education or training they might not otherwise be able to access.

Saskatoon Community Foundation is a charity itself with ongoing expenses. Contributors to the **Administrative Endowment** recognize the importance of building the Foundations' capacity to lead and serve the community.

Agency Endowments are funds established by charities to generate annual income for their use.

Managed Funds are also established by charities, but are not endowed. The funds can be withdrawn at any time, but benefit from being part of the larger pool of investments.

Community Builders are donors who make deferred gifts—a life insurance policy, a charitable trust, or a bequest by will. Although the gift is deferred, tax benefits can be immediate.

Flow Through Funds are not endowed. Donors may flow funds through the Foundation to the cause of their choice following Canada Revenue Agency regulations. We award flow through grants on behalf of individuals, families, or businesses.

The Saskatoon Fund, home to our memorial, tribute and Century Club donations, is one of the many funds that make up our Unrestricted Fund. Memorial and tribute gifts allow friends and family to donate in memory or in honour of a loved one. Century Club is the club for "everyday philanthropists."
